### **Extra CPZ FAQs for Brent Cross Cricklewood**

# 1) Will we be able to park in our neighbouring roads?

Yes, you will be able to park in any roads included in your Zone. If you hold a Zone GG permit, you can park on Quantock Gardens, Cotswold Gardens, Cleveland Gardens, Grampian Gardens, Cumbrian Gardens, Chiltern Gardens, Malvern Gardens, Cheviot Gardens, Purbeck Drive, Pennine Drive and Mendip Drive.

If you hold a Zone BA permit, you can park on Claremont Road, Prayle Grove, Marble Drive, Wallcote Avenue and Amber Grove, Brent Terrace, Clitterhouse Crescent and Clitterhouse Road.

### 2) Can the parking stress data be made available to the public?

An officer decision report can be found on our webpage Transformingbx.co.uk/cpz which summarises the parking engagement process to inform the design of the CPZ. This includes the analysis of parking data outlined above, as well as results of the informal consultation which took place between March and April 2025.

# 3) Why do we not have marked bays as part of the CPZ design?

The Controlled Parking Zone will consist of 'Permit holders past this point' areas where we provide signs at the entrance to these parking areas, which removes the need for marked parking bays and additional signs. This helps to maximise the kerb space for permit holders within an area. Disabled parking places are also provided in suitable locations. For designated on-street disabled parking bays, blue badge holders can park for free or at pay by phone bays. Blue badge holders can park on single or double yellow lines for up to 3 hours unless there are no loading restrictions.

# 4) Will the CPZ prevent people from parking dangerously and blocking junctions?

Double yellow lines will be installed at junctions or bends within the CPZ area where road safety concerns have been raised to us, sightlines are obstructed and larger vehicles such as emergency services would have issues accessing the roads. These new markings are part of Barnet Council's road safety programme to improve traffic flow/congestion and deter obstructive parking which create issues for pedestrians, drivers, and riders.

#### 5) Will the CPZ prevent people from parking on driveways?

Parking in front of/outside driveways and on dropped kerbs is against the national highways code. Drivers should not stop or park in front of an entrance to a property.

# 6) Will there be CPZ enforcement on Christmas Day and Boxing Day?

Controlled Parking Zones are not enforced on Christmas Day and Boxing Day. Full details of barnet.gov.uk/parking/parking-and-traffic-enforcement/parking-restrictions

# 7) Is there a phone number or are there other ways that elderly residents can use to reach the parking team?

For parking permits, you can reach the parking permit team at 0208 359 7446 (M onday to Thursday 9am to 5.15pm, and Friday 9am to 5pm).

# 8) How will feedback on the CPZ will be considered by the parking team?

During the first six months, we will undertake a statutory consultation where officers will consider comments received, assess the effectiveness of the parking controls, and make changes if required.
